Gardens are giving up their final abundant harvests—including our own garden here—so the beautiful surplus fruits and vegetables our donors bring us are washed and offered to grateful clients. Scholarship awards are going out to young people starting a new year of life-changing education. The spirit of giving is growing stronger…and the holidays are coming.

November begins sweetly as garden greens share space in grocery bags with surplus Halloween candy that our friends drop off. Through the month, we'll provide each client family with a gift card for a turkey and the makings of a traditional Thanksgiving feast; thanks to our donors and local churches who are filling boxes with seasonal ingredients.

By the end of November, we will kick off our popular Holiday Adoption program. Each member of each client family receives some holiday joy, which is often the only gift some clients will receive. From children to seniors, single parents and veterans – no one is left behind during the giving season.

### A Note from Cyndi

The remarkable story I share today is one of service, friendship, trust and legacy.

Carolyn Elsik was a bookkeeper for Shell Oil, and George Burr made his career with AT&T. They met in a Texas dance club. They were single and in their 40s; and after a courtship, they married sometime later. They enjoyed a full life together with boating and biking and wonderful friends.

AT&T took them to Manchester, MO, where George continued on his career path and Carolyn enjoyed early retirement. Together the couple joined Christ, causes that mean the most to you. Prince of Peace Church. It was

there, in the church bulletin, that Carolyn saw a "help wanted" ad for Circle of Concern. So in 1995, Carolyn began her 15-year volunteer tenure at Circle of Concern. Serving beside Circle's then executive director, Glenn Koenen, Carolyn was a bookkeeper, and for a time, board member.

She recruited George to serve too. Upon retirement from AT&T, he signed on as a volunteer driver. Together they volunteered for several years, working at special events and helping wherever there was a need, all the while, watching, as Glenn, Circle's first paid staff member, led Circle to new heights. His passionate advocacy for low-income families, and his careful stewardship of Circle's resources made an impression on the Burrs.

In 2010, George was diagnosed with Alzheimer's disease, and the couple retired from Circle. Carolyn had a parting wish. She asked Glenn to take care of George should anything happen to her.

It wasn't long after that Glenn also retired from Circle - after 17 years as Executive Director. Unexpectedly, Carolyn passed in 2015, and Glenn kept his promise to care for George. He became George's legal quardian, watching over and advocating for him until he passed in August 2020. The courts appointed Glenn to represent George's estate.

Circle's appeals for support.


